

SELF-LIMIT ACCESS PROGRAM



CG Technology is committed to promoting public awareness and education and to providing information on available resources to those patrons who believe they may have a gambling problem. CG Technology maintains a program in compliance with Nevada Gaming Regulation 5.170 that allows our patrons to voluntarily self-limit themselves from certain activities and privileges, as indicated below:

1. I hereby request to self-limit my access to casino privileges, including receiving complimentaries and agree to be removed from all direct mail marketing lists, telemarketing and electronic marketing lists, promotional mail lists and player recognition programs at all Nevada CG Technology properties as applicable.
2. I understand that CG Technology shall continue to honor my request to self-limit my access to the casino privileges described above unless and until I request to rescind the voluntary self-limitation. I shall not be allowed to make such a reinstatement request earlier than 6 months after the effective date of this self-limitation request unless exceptional circumstances exist. Any request to rescind less than 6 months after this self-limitation became effective must be made in writing with a reason given and must be notarized.
3. I have been advised that if I receive any financial gaming privilege, material or promotion covered by this program after the effective date of self-limitation, I should contact the CG Technology Compliance Department at (702) 677-3867 within 10 days of receiving the privilege, material, or promotion. I acknowledge that for my request of self-limitation to be truly effective, I must exercise self-restraint and I should not ask any CG Technology employee to provide me with any of the services or privileges which are the subject of this request.
